# पुरा स्मारकों में लोक गीत के नाम पर द्विअर्थी फिल्मी गानों का अलाप

अगर आप अपने परिवार के साथ जयपुर के स्मारक घुमने के लिए जाते हैं और वहां आपको तेरी तिरछी नजर तेरी पतली कमर..., मोए मोए... जैसे गाने सनने को मिले तो कैसा लगेगा। जी हां, ऐसा ही कुछ हो रहा है प्राचीन स्मारकों पर। गुलाबी नगर के स्मारकों में विभाग की ओर से पर्यटकों का स्वस्थ मनोरंजन करने के लिए लगाए गए लोक कलाकार राजस्थानी गीतों के बजाए द्विअर्थी फिल्मी गाने और दूसरे राज्यों के संगीत को प्रमोट कर राजस्थानी संस्कृति का भट्टा बैठा रहे

कुछ स्मारकों पर इन लोक कलाकारों के कारण पर्यटकों को परेशानी हो रही है। वे सुकून के साथ स्मारक नहीं देख पा रहे। लोक कलाकारों की आवाज में गाइडों की जानकारी दब रही है ऐसे में पर्यटकों को स्मारकों की पूरी जानकारी नहीं मिल रही है। स्मारकों के इतिहास, प्राचीन निर्माण तकनीक, विशेषताओं और तकनीकी पहलुओं की जानकार पर्यटकों को जब तक नहीं होगी, तब तक उनका विरासत टूरिज्म अधूरा है। जंतर-मंतर पर कठपुतली शो करने वाले राजेश भाट ने बताया कि हम तो पर्यटक की डिमांड के अनुसार गाना-बजाना करते हैं। फिल्मी, पंजाबी, हरियाणवी, गुजराती, इंग्लिश गाने सुनाते हैं तो अच्छी टिप मिल जाती है। कठपुतली शो में कुछ गाने राजस्थानी तो कुछ फिल्मी होते हैं। उल्लेखनीय है कि कोरोना काल के दौरान सरकार ने कठपतली

कलाकारों को रोजगार उपलब्ध कराने के लिए स्मारकों में स्थान उपलब्ध कराया था। सरकार की मंशा थी कि इससे देशी-विदेशी पर्यटकों के सामने राजस्थान की कला और संस्कृति का प्रचार-प्रसार होगा, लेकिन हो इसका उलट रहा है। कलाकार ज्यादा पैसा कमाने के चक्कर में राजस्थान को भलकर फिल्मी और अन्य प्रदेशों के गीतों को प्रमोट कर रहे हैं।

जानकारों के अनुसार जगह देने से पहले सरकार को यह तय करना चाहिए था कि कलाकार स्मारकों में सिर्फ राजस्थान की कला संस्कृति को ही प्रमोट करेंगे। कठपुतली नृत्य के साथ सिर्फ राजस्थानी लोकगीत ही गाए-बजाए जाएंगे। कलाकार राजस्थानी वेशभूषा से सुसज्जित होंगे, यहां तक कि उनका केश-विन्यास भी राजस्थानी लोगों की तरह ही होगा।

### यह हो रही परेशानी

स्मारकों पर कलाकार लपकों की तरह पर्यटकों को लपकने की कोशिश में जुटे रहते हैं, ताकि उन्हें ज्यादा से ज्यादा नेग मिल पाए। ऐसे में वह अच्छी तरह से स्मारक को देख भी नहीं पाता है। कलाकारों को हवामहल में अंदर स्थान दिया गया है। हॉल के अंदर उनके गाने की आवाज काफी गुंजती है और वह गाइडों की ओर से बताई जा रही स्मारक की खुबियों को नहीं सुन पाते हैं।

जंतर–मंतर ज्योतिष वेधशाला है और एक तकनीकी स्मारक है जहां 95 फीसदी पर्यटक गाइड लेते हैं, ताकि उन्हें यहां के यंत्रों की तकनीक समझ में आ सके। इस दौरान कलाकार पहुंच कर कठपुतली शो देखने के लिए बुलाने पहुंच जाते हैं। कुछ यंत्रों के पास इनके गाने की आवाज तेज आती है, जिससे पर्यटक गाइड की बातों को सून-समझ नहीं पाते हैं। इसके अलावा आमेर महल, नाहरगढ़ फोर्ट और अल्बर्ट हॉल में भी कठपुतली कलाकारों को जगह दी गई है।

### शिकायतों से कोई सरोकार नहीं

अकसर पर्यटक लोक कलाकारों की शिकायतें गाइड को करते हैं। गाइड इन शिकायतों को स्मारक प्रशासन के पास पहुंचा देते हैं, इसके बावजूद कठपुतली कलाकारों की जगह दोबारा निर्धारित करने के लिए कोई कदम नहीं उठाया जा रहा। गाइड भी इस मामले में सीधे कुछ बोलने से बच रहे हैं।
